

Our Privacy Policy

This privacy policy sets out how we use and protect any information that you provide to Number One Seagate, either directly, through our website www.numberoneseagate.co.uk or through other websites where we advertise.

We are committed to ensuring that your privacy is protected. Should we ask you to provide certain information by which you can be identified when using our website, then you can be assured that it will only be used in accordance with this privacy statement. Number One Seagate may change this policy from time to time by updating this document and it will always be accessible for you to check from time to time to ensure that you are happy with any changes. This policy is effective from 1st January 2021.

When this policy mentions "we," "us," or "our," it refers to Number One Seagate, holiday home. The data controller for Number One Seagate is Sarah Pestridge who may be contacted by email at sarah@numberoneseagate.co.uk.

Information We Collect

In general, you may visit the site without telling us who you are or revealing any personally identifiable information about you. Our server collects the domain names, operating system in use (e.g., Macintosh, Windows) and browser (e.g., Netscape, Internet Explorer). This information is summarised to measure the number of visits, average time spent on the Site, pages viewed, etc.

We use this information to measure the use and to improve the content of our website.

Personally identifiable information such as first and last name, telephone number, email addresses and other information are known only when voluntarily provided by a visitor for registration, booking requests or other participation of visitors in any available online interactive activities.

Information We Collect From Third Parties

We may collect information from you via a third party e.g. if you submit an enquiry to us via a 3rd party website (i.e. Airbnb). In this case we treat this information in the same way as if we had received directly from our own website. However, any information submitted sent in this way may be stored by them according to their privacy policy.

Use Of Your Information

We may use the personal information you provide for any of the following purposes:

- 1. to fulfil a booking request;
- 2. to provide customer service;
- 3. to understand the use of our website and make improvements;
- 4. respond to specific requests from visitors;
- 5. protect the security or integrity of our website when necessary;
- 6. send you notices and solicitations regarding the website and our businesses;
- 7. to occasionally promote and market products to you. These solicitations may take the form of mail, telephone calls, e-mail solicitations and other methods of contact. We will only send these to you if you have agreed to receive them. At any time if you do not want to receive these solicitations from us using your personally identifiable information, please notify us.
- 8. profiling and automated decision making We use data collected to improve our relevance to you. For example we collect data through interaction with our website (such as what content you view) as well as information about how you came to our site in the first plan (for example, what advert did you click on) and activity within our emails (what emails you open and when, what content you click on) and we use this to send you emails you are interested in, or show you content, or offers that more closely fit what you look at. This kind of activity does not have legal or otherwise significant effect on you.

At times, we may conduct online surveys to better understand the needs and profiles of our visitors. When we conduct a survey, we will try to let you know how we will use the information at the time we collect the information from you on the Internet.
